**NOTICE INVITING BIDS**

Sealed bid offers under **TWO BID SYSTEM** are hereby invited by the Govt. of Arunachal Pradesh from eligible commercial permit holders **under DGCA, India (Non-scheduled category)** having tendered type of helicopters, for **WET LEASE of Dauphin (twin engine) or similar type/capacity (10 - 13 seater) twin engine helicopter of latest/modern technology, not more than 15 (fifteen) years of age as on the date of opening of tender** for passenger flight service etc. in Arunachal Pradesh and adjoining areas under 75% subsidy scheme of Ministry of Home Affairs, Government of India, **for a period of 2 (two) years** from the date of signing of agreement/positioning of helicopter whichever is earlier with provision for extension for **1(one) year** at the same rates, terms & conditions subject to continuation of Helicopter subsidy scheme by the Ministry of Home Affairs, Government of India, in prescribed bid form and proforma:-

3. Bidder is to deposit **Bid Bond (Earnest Money) of Rs.50.00 lakh (Rupees fifty lakh) only** in the form of Bank Guarantee as specified in the Detailed Tender Documents.
