**NOTIFICATION**

**Sub:- Chief Minister's District Innovation and Challenge Fund.**

The Government of Arunachal Pradesh has decided to implement the Scheme of "**Chief Minister's District Innovation and Challenge Fund**" to ensure that public investment in the district is responsive to local requirements of the districts. The following would be the key objectives of the scheme:

- (a) To fill in vital gaps in public infrastructure available at the district level which is not being fully utilized in absence of relatively small investment e.g. Government hospital with non-functional diagnostic equipment.
- (b) Catalyze opportunities for Skill Development, Sustainable Livelihood and entrepreneurship.
- (c) Schemes which have positive impacts of efficient service delivery system.
- (d) Schemes which are oriented towards social sectors - Health and Education.
- (e) Schemes which are targeted on welfare of marginalized section of the society.

(f) Development of Eco-tourism.

In order to achieve the schemes, Deputy Commissioners would constitute a Team of officers available in the district and conceptualize proposals for consideration of the Government. The following will be the key modalities for operationalizing the scheme:

- (i) The annual budget proposal for the schemes would be a minimum of Rs. 2.00 crore and maximum Rs. 10.00 crore.
- (ii) The scheme will not be allotted by virtue of entitlement but would be selected through a competitive process.
- (iii) Implementation in any case must not spill over beyond the financial year 2018-19. A clear break-up of expenditure required in 2017-18 and 2018-19 be indicated.
- (iv) The proposal must be locally relevant and self-sustaining. Possibilities of engaging local communities or NGOs may be explored for management & resources, avoiding the creation of posts or recurrent expenditure.
- (v) For infrastructure creation, execution must be done through a transparent process of tendering as per the guidelines of CVC through the concerned Works Departments as per Allocation of Business Rules.
- (vi) Payment will be released in three tranches – 10%, 50% and 40% based on submission of utilization Certificates.
- (vii) The project proposals may be submitted in the format given at Annex. I.

The project proposals will be screened by a State Level Screening Committee with the following composition.


1. Development Commissioner (Fin,Plg&Invt) : Chairman

5. Secretary (Skill Development) : Member

The project proposals may be submitted by the concerned Deputy Commissioners latest by 30.6.2017 and eligible project would be sanctioned by 15.7.2017.

Deputy Commissioners will be required to submit quarterly progress reports in format enclosed at Annex-II and submit a project completion report in Annex-III.

Choice of the project team will be crucial and officer who is committed to development may be made project manager regardless of the work assigned to him as his/her normal official duties.


