Women Achievers Awards- State Award for Women- Guidelines

 The Women Achiever's Award is conceptualized with the aim to honour, appreciate and recognize the contributions of emerging extraordinary women who come from diverse backgrounds and professions, those who have not only excelled in their respective fields but have also acted fearlessly to change the society for the better.

This Award is also meant to put the spotlight on the accomplishments of these exceptional women and institutions in recognition of their service towards the cause of women especially to vulnerable and marginalized women.

It has been decided by the Government that the Awards will be presented every year on the 8th of March on the occasion of International Women's Day.

For all purposes, 'Award' means the State Women Achievers Awards

2. Objectives:

This is a concerted effort by the state government to confer the 'Women Achievers Award' to women and institutions to show its commitment towards the upliftment of women, to recognize their contributions and to encourage women to participate in all spheres and issues related to women.

This Award will also provide an opportunity to act as an inspiration for the general populace; individuals and institutions to aspire for and to understand the contributions of women in the building of society and the nation.

3. Description

The recipients of the award will be announced every year on 20th of February and the award will be conferred on the 8th of March on the occasion of International Women's Day.

The award shall be awarded in two categories, individual & Institutional category. The maximum number of awards would be 15 in total. Out of which 10 Nos. Awards would be conferred to (ten) individual Women @ 75000/-(Rupees Seventy five thousand) only each and 5 Institutions/NGOs controlled by Women @ 1,00,000/- (Rupees one lakh) only. Each Institution/ NGO Awardee of Women Achiever Award of any Institutions/NGOs will not be considered for individual Award.

The award in each category shall carry a certificate with cash amount/Demand draft/Cheque as per decision of Nodal Department as mentioned at 3.2 above.

4. Eligibility Criteria for Nomination:

The awards are open to all individual women and institutions/NGOs runby Women within the State of Arunachal Pradesh.

In case of individual category, the awardee must be at least 18 years of age on the last date of receipt of nomination and also be APST Category to be eligible for the award. If the applicant is an institution, it should have worked in the relevant field for at least 5 years in the State.

The applicant should not be a recipient of the same award earlier.

The award may be awarded for outstanding work, preferably in exceptional circumstances to individuals/ institutions /NGOs, Groups etc. run by Women in the following fields:

7. Nominations

Nominations for the award will be invited from Individuals and Institutions working for the empowerment and causes of women. However for the Institutions, it should have worked for at least5 years prior to the year for which the nomination is invited.

The nominations will be sent to the Department of Women and Child Development, Itanagar, Govt. of Arunachal Pradesh with details as per Annexure-I and Annexure-II along with supporting documents/recommendation through the concerned Deputy Commissioners.

The entities at para 5 recommending the nominations should clearly certify the work carried out by the nominees for which the award is being recommended.

8. Screening and recommendation of the nominations

A Screening –cum- Recommending Committee shall be constituted by the Deputy Commissioner of each of the 25 districts of Arunachal Pradesh to scrutinize and short list the nominations received for the Felicitation of Women Achiever Awards considering the achievements of the individuals.
