The Department of Land Management, Government of Arunachal Pradesh invites sealed quotation from BSICS accredited, ISO 9001:2015 certified credible in Remote Sensing, SurveyingandGISapplication for undertaking Cadastral Survey/Re-survey, Mapping in GIS environment and preparation of Record of Rights (RoR), etc of Raga Township under Kamle District and Rego Perging under Siang District, Boleng having geographical area of 5 SqKm each.

The preference shall be given to the empaneled Companies/Firms with the DILRMP in such survey worksor having workingexperiencein the state of Arunachal Pradesh or undertaken such similar projects in any North Eastern States or HillyAreas, etc.

The estimated cost of Rs.35.00 lakhs (Rupees Thirty-Five Lakhs) only is kept for Rego Perging under Siang District, Bolengand an estimated cost of Rs.30.00 lakhs (Rupees Thirty Lakhs) only for Raga under Kamle District.

4. Terms and Conditions:

a) The "consultant/agency" should be empaneled with DILRMP or reputed, credible Remote Sensing & GIS based company (should be empaneled Vendor of State Remote Sensing Organizations or NRSC or other State Government Departments etc.) with outstanding satisfactory and proven experience in large scale mapping,

mapping etc. using the GIS and RS technology.

- **b)** They should preferably also have experience in high resolution satellite data using digital image processing techniques.
- c) The "Consultant/agency" should be empaneled with DILRMP or have a full-fledged and highly specialized human resource team with a high degree of technical expertise of at least 10 GIS Engineers, 15 Surveyors on pay roll basis including its own well established Remote Sensing & GIS setup, requisite remote sensing & GIS hardware, field equipment (at least 2 DGPS and 5 Electronic Total Station) etc. necessary documentary evidence in support of possessing these instruments by the "consultant/agency" shall be submitted along with the technical bid. The technical team from Directorate of Land Management may inspect the facilities of the consultant/agency to ascertain, if required.
- d) The "consultancy/Agency" should be empaneled with DILRMP or have completed project of value not less than Rs.100.00 Lakhs in the last financial year or should be executing projects of value not less than Rs.100.00 Lakhs in the current financial year involving the said technologies.
- e) The "consultant/agency" shall furnish solvency certificate to the tune of Rs.100 Lakhs (Rupees One Hundred) Lakhs from any bank in support of its sound financial standing.
- f) The consultant/agency should be an ISO 9001:2015 and 27001:2013 certified firm or authorized business partner of an ISO certified firm for providing consultancy technical service in RS, GIS, GPS surveys and mapping. The organization should bear BSICS accreditation.
- g) The consultancy/agency should have executed similar GIS & Remote Sensing mapping projects in India preferably North Eastern Hilly regions for of at least 200 sq. Km and have created detailed plot wise mapping at least in five towns in North East India and its adjoining villages.
- h) Preference will be given to the consultant/agency empaneled with the DILRMP or those having carried out Remote Sensing/GIS based studies in the state of Arunachal Pradesh.
- i) The "Consultant/Agency" shall deposit Rs.1,20,000/- (Rupees One Lakh Twenty Thousand Rupees) only as Earnest Money Deposit. For this purpose, an account payee Demand Draft/Bank guarantee for the said amount drawn at any Nationalized Bank, in favor of Director of Land Management, Govt. of Arunachal Pradesh, Itanagar, payable at Itanagar shall be enclosed with the technical bid. The quotation without earnest money deposit shall be summarily rejected.
- j) The Technical bid and financial bid shall be submitted separately by each firm and each envelope cover shall indicate the contents of the Bid Documents (Technical/Financial) and the name of the Firm.
