2. The rates should be quoted both in figures and in words any correction or overwriting should be attested.
3. The quotation should be inclusive of GST and all applicable taxes.
4. The word "Quotation for Supply, Installation, Testing and Commissioning of 10Mbps Internet Lease Line Connection to the 8 Prisons of State" should be super scribed on the body of the envelope.
5. Quotations should deposit earnest money (EMD) amounting to Rs. 74,400/- (Rupees Seventy Four Thousand and Four Hundred) only in DD from any Scheduled Bank in favour "Director cum Member Secretary, SCITeG".
6. Interested TSPs intending to participate in the Bid may purchase the same by submitting cash or Demand Draft (DD) drawn in favour of "Director cum Member Secretary, SCITeG" for Rs.2000/- as document fee.
7. The total cost of the project is Rs. 37, 20,000/- (Rupees Thirty-Seven Lakhs Twenty Thousand) only.
8. Vendor must provide 4 port managed router.
9. An MoU will be executed within the Dept. of IT and the selected TSP, and the contract period is expected to be 5 years.
