### **ADVERTISEMENT**

The Government of Arunachal Pradesh hereby invites applications from eligible citizens of India in prescribed form at Annexure-A, for filling up 1 (one) post of Chairperson and 1 (one) post of Non-Judicial (APST) Member of the Arunachal Pradesh State Lokayukta.

1 (1) Requisite qualification for appointment of Chairperson of the Arunachal Pradesh Lokayukta

A person who is or has been a Judge of the Supreme Court or who is or has been Chief Justice or Judge of High Court and of impeccable integrity and outstanding ability; or,

An eminent person of impeccable integrity and outstanding ability having special knowledge and expertise of not less than twenty years in the matters relating to public administration, finance including insurance and banking, law, anti-corruption policy or management.

(2) Requisite qualification for appointment of Member of the Arunachal Pradesh Lokayukta (Non-Judicial APST Member preferably woman).

An eminent person of impeccable integrity and outstanding ability having special knowledge and expertise of not less than twenty years in the matters relating to public administration, finance including insurance and banking, law, anti-corruption policy or management.

- 2. A person applying for the post of the Chairperson or the Member of the Arunachal Pradesh Lokayukta shall not be eligible if he/she is/was-
  - (i) A Member of Parliament or a member of the Legislature of any State or Union territory; or
  - (ii) A person convicted of any offence involving moral turpitude; or
  - (iii) A person of less than forty five years of age, on the date of assuming office as Chairperson or Member, as the case maybe
  - (iv) A Member of any Panchayat or Municipality;
  - (v) A person who has been removed or dismissed from services of the Union or a State; or

- (iv) A person holding any office of trust or profit (other than his office as a Chairperson or a Member) or person connected with any political party or carrying on any business or practicing any profession, and accordingly, before he enters upon his office, as the Chairperson or a Member, as the case may be, shall, if-
  - (a) he holds any office of trust or profit, resign from such office; or
  - (b) he is carrying on business, sever his connection with the conduct and management of such business; or
  - (c) he is practicing any profession, cease to practice such profession.

# 3. Tenure of the posts:

The Chairperson and the Member of the Arunachal Pradesh Lokayukta shall hold office for a term of 5(five) years from the date on which he enters upon his office and shall not be eligible for reappointment thereafter.

#### 4. Salaries and Allowances:

- (i) The salaries and allowances of Chairperson of the Arunachal Pradesh Lokayukta shall be the same as those of the Chief Justice of High Court of Gauhati as prescribed under the Arunachal Pradesh Lokayukta (Condition of Service) Rule, 2018.
- (ii) The salaries and allowances of person appointed as Member of the Arunachal Pradesh Lokayukta shall be the same as those of a Judge of the High Court of Gauhati as prescribed under the Arunachal Pradesh Lokayukta (Condition of Seryice) Rule, 2018.

# 5. Procedure for Applying for the Posts:-

All applicants whether nominated or directly applying in response to the advertisement must submit their applications duly filled in the prescribed proforma in Annexure -"A".

Applications not received in the prescribed proforma will be summarily rejected.

6.
