Interested students are instructed to apply ONLINE by registering themselves on the National Scholarship Portal ([www.scholarships.gov.in](http://www.scholarships.gov.in) / <https://scholarships.gov.in>). **Eligibility Criteria & Conditions for Applicants:-**

1. Applicants are instructed to follow the instructions carefully before filling out the online application on the National Scholarships Portal (NSP) using the provided link.
2. The candidate must be an APST.
3. His/her parental/guardian's income should not exceed Rs. 2.5 lakh per annum.
4. He/She should not be receiving any other centrally funded Pre-Matric Scholarship.
5. The student must be a regular student studying in a government school or a school recognized by the government or a Central/State Board of Secondary Education.
6. Scholarship for studying in any class will be available for only one year. If a student repeats a class, he/she will not be eligible for a scholarship for that class in subsequent years.
7. The candidate must have an Aadhar-based/seeded bank account, preferably in the State Bank of India.
8. Institute Nodal Officers (INOs) are directed to guide students in filling out the online application form to prevent any errors by the students.

9. After the last date for online application submission, incomplete or partially filled applications will not be entertained under any circumstances.
